- I. Opening

  - B.. Schools represented – Bethany, Bloomington, Christ, Cross of Christ, Crown of Life, Good Shepherd, Holy Trinity, King of Grace, Mt. Olive, Pilgrim, Salem-Greenfield, Salem-Stillwater, St. John-STP, St. Croix LHS
- II. Secretary/Treasurer’s Report
  - A. Minutes of August 5, 2008, meeting distributed (M/S/A)
  - B. Treasurer’s report distributed (M/S/A)
3. High school reports:
  - A. West LHS – no report
  - B. St. Croix LHS – coaches liked the basketball tournament format
- V. Fall Sports Review
  - A. Soccer – consensus that the season went well;
  - B. Cross-Country - no significant change is expected with Mr. Uhlenbrack’s retirement; Christ Lutheran will continue to coordinate soccer
  - C. Volleyball – “plug” for more volunteer officials

    1. Schedule discussion

      - b. ADs have the flexibility to coordinate mutually agreed upon scheduling changes
      - c. how do we add Holy Trinity to the schedule with only B-teams for the coming season(s)
      - d. other schools with only B-teams or A-teams
    2. **motion** – keep the schedule as published and fit in Holy Trinity (M/S/A)
  - B. Tournaments
    1. the committee was advised that Delano HS gym is available for the full weekend for \$450 rental
    2. the committee requested Mr. Homan to look into the use of Colin Powell Center for Friday and Saturday
    3. **motion** – reimburse Pilgrim Lutheran \$300 for expenses incurred for hosting the tournament at the Colin Powell Center (M/S/A)
